

**DOCUMENTS REQUIRED FOR:  
Permit - Packer Tickets on Game Day  
(To purchase for resale and to resell on Armed Forces Drive)**

- Application form (attached).
- Certificate of Insurance for \$1,000,000 insuring each permit holder, naming the Village of Ashwaubenon as an additional insured.
- Valid form of government issued identification bearing the applicant's photograph.
- Application fee - \$800.00 per season.
- 1-1/2" x 1-1/2" photograph of applicant. (If applicant is able to come to the Village Clerk's office, the necessary photo can be taken at the office, otherwise, applicant must provide photo.) **New photos are required for each season.**

The applicant must buy and sell from the Packer ticket resale area.

**ALL REQUIRED DOCUMENTS MUST BE SUBMITTED TO THE VILLAGE CLERK'S OFFICE SIX WORKING DAYS BEFORE THE PERMIT WILL BE ISSUED. THERE ARE NO EXCEPTIONS.**
